Government vide references 1st to 4th cited, issued certain instructions for utilization of surplus staff of Corporations of similar Public Sector undertakings, Societies and other organizations/bodies etc., who were redeployed to various Government Departments shall be deemed to have been repatriated to the parent organizations. However, the services of the existing re-deployed surplus staff to the Government organizations/bodies etc., shall be treated as deputation and the emoluments like salary, leave salary, EPF contribution etc., of the staff deployed to other departments on deputation shall be paid by the concerned corporations or similar public sector undertakings, societies, or other organizations/bodies etc. After receipt of request from the concerned corporations or similar public sector undertakings, societies, or other organizations/bodies etc., the borrowing departments shall reimburse the amount paid to the staff duly debiting the same to the detailed Head 280 - professional services/ 284 - Other Payments to respective service Head of the department.

2. In the reference 2nd cited, the Director and Treasuries has requested to issue necessary clarifications on the following points;
- extension of Revised Pay Scales, 2020 is applicable to re-deployed employees who are drawing salaries under 280/284 instead of "010-salaries".
 - whether to continue deduction of GPF subscriptions if their salaries are reimbursed under the detailed head 280/284.
3. Government after due examination of the matter, hereby direct the Director of Treasuries and Accounts to take action for extension of Revised Pay Scales, 2020 to the employees from the Corporations redeployed to the Government institutions with specific orders of the Government and drawing salaries under 280/284.
