ORDER:

In the Government order first read above, Government sanctioned Special allowance of 50% on Basic Pay +DA to all officers of and above rank of Addl. Superintendents of Police working in Counter Intelligence Cell on par with SIB and Special Allowance of 50% on Basic +DA plus 10% on Basic pay to all the personnel of and below the rank of Deputy Superintendents of Police working in the CI Cell on par with SIB.

2. In the Government order second read above, based on the recommendations of Tenth Pay Revision Commission, orders were issued implementing the Revised Pay Scales, 2015 to the Government employees.

3. In the Government order third read above, based on the recommendations of Tenth Pay Revision Commission, orders were issued to continue payment of Special Allowance to certain categories of posts belonging to 'Grey Hounds' unit of Police Department, Special Intelligence Branch and Counter Intelligence Cell of Intelligence Department in Revised Pay Scales, 2015 as per Annexure appended to it.

4. In the reference fourth read above, the Home Department informed that all the personnel of and below the rank of Deputy Superintendents of Police working in the C.I. Cell have been drawing special allowance of 50% on Basic pay + DA thereon plus 10% on Basic pay, per month, on par with the staff of SIB and requested for continuing the Special Allowance at above rates on par with Grey Hounds and SIB.

5. Government after careful consideration hereby order that in the annexure to G.O.Ms.No.59, Finance (HRM.IV) Department, dated 02-05-2015, under sub heading, 'III. Counter Intelligence Cell of Intelligence Department', in respect of the posts mentioned at serial numbers 5 to 9 in Column 2, the rate of Special Allowance to be allowed in the RPS, 2015 shall be read in Column 4 as 50% of Basic pay+ DA plus 10% of Basic pay per month instead of 50% of basic pay per month.

6. These orders shall come into force with effect from 01.05.2015.
7. Necessary amendments to the Manual of Special Pays and Allowance wherever necessary will be issued in due course.


