ORDER:

In the Government Order 3rd read above, orders were issued constituting Ninth Pay Revision Commission by appointing Sri C.S. Rao, IAS., (Retd) as Pay Revision Commissioner. In the Government Order 4th read above, additional terms of reference of the Pay Revision Commissioner were laid down.

2. The Ninth Pay Revision Commission submitted its report to the Government on 05.12.2009 and recommended inter-alia to the effect that the delegation of powers to the authorities indicated by them for sanction of pension to avoid delays in processing of pension papers.

3. Government in the reference first read above have delegated certain powers for speedy disposal of the pension cases as follows:

- (i) Head of the office is the Pension Sanctioning Authority for all Non-Gazetted Officers including Class-IV Employees.
- (ii) If the Head of the office is a Non-Gazetted Officer, the next authority who is a Gazetted is the Pension Sanctioning Authority.
- (iii) Head of the Department is the Pension Sanctioning Authority in case of Gazetted Officers of various Departments i.e., other than Secretariat Departments.
- (iv) In case of Heads of Departments and Gazetted Officers in all Departments of Secretariat including Finance and Law Departments, Secretary of the concerned Department in the Secretariat is the Pension Sanctioning Authority.

4. Government in the reference second read above have simplified the pension forms so that the retiring incumbent receives his pensionary benefits immediately after his retirement.

5. Government after careful consideration of the Report, have decided to accept the above recommendations of the Pay Revision Commission and hereby order that in the departments where there are the Regional / Zonal Offices, the concerned Regional / Zonal Officers are authorized to accord sanction for pension in respect of all the Gazetted Officers working under their control. The Head of the Department is authorized to accord sanction for pension cases in respect of Regional / Zonal Officers only. If in any department there are no Regional/Zonal Officers, but only District level officers, the cases of pensions of such District Level Officers may be sanctioned by the Head of the Department.
