3	Mentally Retarded Children	:	Relevant Certificate issued by the competent authority.
4	Medical Grounds	:	Certificate from the Hospital where the treatment is Undergoing in respect of diseases specified at para III (a) (vi) in the GO
6	Office Bearers of recognized Association	:	Shall furnish the necessary orders electing as Office Bearer of employees unions recognised, by the Government (See para para IV (c) in the GO
