**ORDER:**

In the reference cited, the Secretary to Government of India, Department of Expenditure, Ministry of Finance, New Delhi has directed to Set up State Project Management Unit (SPMU) and informed that the Union Cabinet has approved a four-tier structure for administration of the Public Finance Management System (PFMS) scheme. It included setting up of a State Project Management Unit (SPMU) and District Project Management Unit (DPMU) in each State. The posts approved for the SPMU also include one post at the level of Junior Administrative Grade and requested the State Government to support in filling this post up on deputation basis with prior experience of Treasury and Budget operations at the State Government is desirable.

Government after careful examination hereby constitutes a State project Management Unit (SPMU) with the following members to regularly review and monitor the implementation of Public Finance Management System (PFMS) in the State of Telangana.

- b) Shri Ch.V. Sai Prasad, IA & AS, Joint Secretary to Government, Finance Department, TS Secretariat as Nodal Officer from State Government.
- c) Additional Director, Treasuries and Accounts (in charge Director), Finance(PMU)Department as Ex-officio incharge to look after PFMS.
- d) Sri K. David Raju, Deputy Controller of Accounts, CBEC, South Zone, Chennai, ASNO from Government of India.
