Sub: P.S - Treasuries and Accounts Department -Court cases-Filing of Counter Affidavits in old cases as well as in new cases - Instructions - Issued - Reg.

Ref: 1. Lr. No. Services.I/HC, Dt 07.06.2023 of Government Pleader for Services-I.

Vide reference 1st cited the Government Pleader for Services.I (at Hon'ble High Court of Telangana) has informed that "*the Court is not granting time for filing of Counters in all old as well as new matters. Failing to file counter, the court will pass order based on the record available and may impose heavy cost or appearance*".

In this connection, a Video Conference was held on 09.06.2023 with all the DDs/DTOs of T&A Department and the following instructions were issued to curtail delay in filing counter affidavits in all Court cases, wherein the officers of T&A Department are made respondents.

- i. Brief facts of case/Instructions shall be prepared in every case for submission to the Government Pleader, as and when required /sought for.
- ii. The status of Cases, wherein counters are filed, shall be verified in Telangana High Court Website (<https://tshc.gov.in>) and e-courts Website (<https://e.courts.gov.in>) on daily basis by the Head of the Office.
- iii. As and when the Orders are passed in the court cases, matter shall be appraised to the competent authority immediately for taking necessary course of action on the orders passed by the Hon'ble courts.
- iv. Wherever it is felt that Writ Appeal/ Review Petitions are required to be filed on the orders passed by the Hon'ble Courts, immediate action should be initiated by obtaining opinion/advice of the Government Pleader/Public Prosecutor concerned.
- v. All the Heads of Office shall Co-ordinate with the DTA's Office and Government to get the Para wise Remarks approved for filing Counters and for implementation of court orders without loss of time.
- vi. Any delays which cause for filing of contempt petition and rejection of Appeal/Review petitions, on the grounds of delay, will be viewed seriously.

All the officers mentioned in the address entry are once again directed to comply with the above instructions scrupulously and file Counter Affidavits immediately in all cases pending as on date and they shall follow the same procedure in respect of the ensuing court cases also.

Any deviation in complying with the above instructions will be viewed very seriously and disciplinary action will be initiated against the persons responsible for such failure.
