ORDER:

Government vide reference second read above, orders were issued sanctioning Interim Relief (IR) to all Government Employees/ Pensioners, including the Employees of the Local Bodies (PR and ULBs) and the Government institutions receiving Grants-in-Aid and Work Charged Employees who are currently drawing the pay in the Revised Pay Scales, 2020.

02. In the reference 6th cited, the Public Enterprises Department has requested to issue guidelines for implementation of Interim Relief to Public Sector Employees Federation, Societies and non-teaching staff of Universities in Telangana State.

03. Government after careful examination of the proposal, hereby order for extension of Interim Relief @5% on the basic pay to the regular employees of Public Sector Employees Undertakings and Cooperative Societies/ Staff of Societies and non-teaching staff of universities on par with State Government Employees and Pensioners, subject to following the following guidelines;

- a. The Interim Relief is applicable to the employees of those Institutions which adopted State Government Revised Pay Scales, 2020.

- b. While adopting the extension of Interim Relief, no deviations shall be made to increase the Relief. However, a lower rate may be adopted based on financial viability
 - c. The Interim Relief shall be adopted only when the Dearness Allowance and other allowance are being paid on par with those being paid by the Government as per Government formula.
 - d. The financial commitment in adopting the Interim Relief shall be met from their internally generated resources without any budgetary support and increase in the managerial subsidies and Government Grant.
 - e. In respect of State Level Public Enterprises and Co-operatives the adopted Government order on Interim Relief shall not lead to incurring of losses by the State Level Public Enterprises.
04. The Interim Relief is also applicable to the Pensioners (Non-Teaching Staff) of the Universities, State level Co-operative Institutions and Societies who are drawing salaries / Pensions as per Revised Scales of Pay, 2020.
05. The concerned administrative departments are requested to take necessary further action in the matter, accordingly.
