  - ii. AQP on Basic Pay shown separately be ignored.
  - iii. D.R. is admissible on AQP time to time enhancement.
  - iv. If he / she completed 70-years age in the middle of the month, the AQP is payable Ist of the same month.

- \* Basic Pension + Dearness Relief + Addl. Quantum of Pension + Interiem Relief + Medical Allowance, in the lumpsum amount equal to one months pension subject to a Minimum Pension of Rs. 20,000/- (G.O.Ms. No. 100 Fin. - 24. In respect of Pensioners drawing two Pensions viz. service pension and family pension. Both pensions shall separately be eligible for enhancement to a minimum of Rs. 9,500/- p.m. The employed Family Pensioner shall not be entitled for payment of Dearness Relief on family pension irrespective of the fact that he/she is getting Dearness Allowance on his/her Pay. - 25. The Govt. employees who are appointed on compassionate grounds shall not be entitled to the Dearness Relief on Family Pension Vide G.O. Ms. No. 55 Fin. Dept. (HRM-V) dated. 11-6-2021 Para 24.
- 26. As per Law Divorce is not valid unless it is decreed by the competent court. The agreement reached in front of caste elders is not be a valid divorce. - 28. All the DDO's should furnish a list of employees due to retire next six months of a Calender year (i.e. January to June & July to December) to the salary bill of DDO's for the month of January & July every year. (vide Govt.Cir.Memo No. 459/84/PSC/2009 dt: 11-5-2009)
- 29. The Pension sanctioning authority should append a certificate in the Pension papers stating that "They have verified the services with reference to pay rolls, Pay fixations, including the A.A.S. Appointments / Pay fixations from time to time till the date of retirement. (vide Govt.Cir.Memo.No. 42/PSC/2012 dt: 17-2-2012 of Fin.(PSC) dept)

The Arrears upto Rs. 5,00,000/- (Rupees Five Lakhs only) may be paid and above Five lakhs, Finance Dept., permission is required. The Pension may be paid from the date of appearence under SR 86 & Instn.60 of TR 16 of Try Code Vol-I and vide G.O.Ms. No. 38 Fin. (TFR) Dept., dt. 5-6-2020 TR.16. Inst. 60.
- 36. The Pension not drawn for Three years shall cease to be payable and send the Both halves of PPOs' to the AGTS, Hyderabad for cancellation. Under SR 87 & Instn.60 of T.R.16 of Try Code Vol-I.
