Sub: Public Service – National Pension System – Treasuries and Accounts Department – Deactivation of **redundant DDO Registration Numbers** lying with Central Recordkeeping Agency i.e., NSDL – Deactivation of Errors in the data base mapped to the DDO Registration Numbers, if any, Confirmation for deactivation of redundant DDO Reg. No.s – Sought for – Regarding.

All the Treasury Officers in the State are informed that as per the DDOs list under NPS communicated by the Central Recordkeeping Agency, i.e., NSDL, so far, 30300 DDOs registration No.s have been issued by the NSDL in Telangana State (excluding State Autonomous Bodies) under National Pension System. The breakup is as under

In this connection, it is observed that out of 28558 DDO Registration No.s issued to District Units, more than 50% of DDO Registration No.s are **redundant** as they were issued prior to reorganisation of Districts in Telangana.

It is also noticed that various active DDO registration No.s are mapped with certain incorrect details such as District Name, Office name, DDO Code, DTO Code etc.

In view of the above, it is decided to rectify the details, if any, mapped to active DDO Registration Numbers under NPS and to deactivate the **redundant** DDO Registration Numbers.

As such, Treasury wise lists (in r/o 127 Treasury Units) of all the DDO Registration Number issued by the NSDL is made available in “EXCEL Sheets” on DTA’s website in the following format.

Hence, all the Treasury Officers in the state are requested to go through the lists and indicate the following at appropriate column.

- i) "To keep active" **Or** "to be deactivated" in column No. 7.
- ii) Alteration of DTO Code (issued by T&A Department), if any at Column No. 8.
- iii) Alteration of DDO Code (issued by T&A Department), if any at Column No. 9.
- iv) If any other changes are required in the particular DDO Registration No., the same may be intimated by adding Column 10 as remarks.

The lists duly filled with proposed rectifications/recommendations shall be attested by the Treasury Officer concerned and scanned copies of attested lists may be sent to the email ID cpstshyd2018@gmail.com. The Treasury Officers need not send any physical copies to the O/o DTA, TS, Hyderabad.

The information shall be sent to the above said mail ID by 26-09-2019 positively. Any delay in the matter will be viewed seriously.
