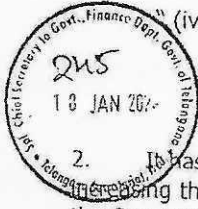

The attention of all the Departments of Secretariat, is invited to the reference 1st cited. In the G.O. first cited, orders were issued amending FR 53 (1) (ii) (a); by adding the following:-



(iv) The amount of subsistence allowance shall be restricted to 50% in all cases where a prima-facie case is established on charges of corruption, misappropriation and demand or acceptance of illegal gratification until finalisation of the disciplinary case".

2. It has been brought to the notice of the Government that some Departments are amending the subsistence allowance up to 75% without following instructions issued by the Government, vide GO 1st cited, even in the cases registered by the Anti-Corruption Bureau on charges of corruption, misappropriation and demand or acceptance of illegal gratification, in a routine manner instead of restricting the same to 50% until finalization of the case.

3. All the Departments of Secretariat/HoD's/Collectors are therefore instructed to follow the instructions issued in the G.O.Ms No.2, Finance (FR.II) Department, dt.04.01.2006, scrupulously without any deviation.

4. These instructions are issued with the concurrence of the Finance Dept., vide U.O.Note No.2248953/193/A2/HRM-III, dt.04.01.2024.


