**ORDER:**

Government of India vide reference 1<sup>st</sup> read above have issued new guidelines for transfer of amount released under Centrally Sponsored Schemes into the concerned Scheme implementing department SNA account along with the State Share. Accordingly, the State Government vide reference 2<sup>nd</sup> read above has issued operational procedure for implementing Single Nodal Agency Account under SNA mechanism.

2. Government of India vide reference 3<sup>rd</sup> read above has informed that Rule 230(7) of GFR 2017, which prescribes that the Principles of 'just in time release' should be applied for releases in respect of all payments to the extent possible and to bring about more efficiency in cash management at both Centre and States level and that it has been decided to introduce an alternative fund flow mechanism named SNA-SPARSH (Real time System of Integrated Quick Transfers) for Centrally Sponsored Scheme funds by using tripartite integration between Public Financial Management System (GOI-PFMS), Integrated Financial Management and Information System (State-IFMIS) and e-Kuber platform of Reserve Bank of India in a progressive manner and envisaged a new procedure to be followed by State Governments and Ministries/ Departments of Government of India for implementation of Centrally Sponsored Schemes in SNA-SPARSH model.
